**AMENDMENT TO THE DECLARATION OF
COVENANTS, CONDITIONS AND RESTRICTIONS
FOR THE COTERIE II SUBDIVISION, PHASE III**



Pursuant to the majority vote conducted at the annual Coterie Townhouse Association (the "Association") meeting conducted on July 14, 1999, Article VI of the Declaration dated December 15, 1977 is hereby amended as follows:

Amendment No. 1 to Article VI:

The Board of Directors for the Association is not authorized to make any extraordinary expenditure on behalf of the Association in excess of Two Thousand Five Hundred Dollars (\$2,500.00). Expenditures in excess of Two Thousand Five Hundred Dollars (\$2,500.00) shall be approved or disapproved by a majority vote of Class A Members of the Association who cast a vote. Class A Members shall be entitled to one vote for each Lot in which they hold an interest. The requested expenditure shall be discussed and voted upon at an Association meeting scheduled after written notice is provided to each member. Written notice describing the expenditure to be voted upon and of the date, time and location of the meeting to conduct the vote shall be placed in each member's mailbox ten (10) days prior to the meeting, or sooner, as circumstances dictate. Those members who do not attend the meeting and wish to vote are solely responsible for casting their vote in writing, signing their vote, and having their vote presented at the meeting.

Amendment No. 2 to Article VI:

The Board of Directors for the Association is not authorized to enter into any contractual obligation on behalf of the Association in excess of Two Thousand Five Hundred Dollars (\$2,500.00). Requested contractual obligations in excess of Two Thousand Five Hundred Dollars (\$2,500.00) shall be approved or disapproved by a majority vote of the Class A Members of the Association who cast a vote. Class A Members shall be entitled to one vote for each Lot in which they hold an interest. The requested contractual obligation shall be discussed and voted upon at an Association meeting scheduled after written notice is provided to each member. Written notice describing the contractual obligation to be voted upon and of the date, time and location of the meeting to conduct the vote shall be placed in each member's mailbox ten (10) days prior to the meeting, or sooner, as circumstances dictate. Those members who do not attend the meeting and wish to vote are solely responsible for casting their vote in writing, signing their vote, and having their vote presented at the meeting.

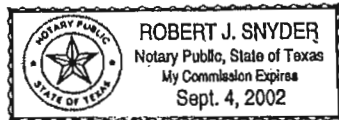
